As a Retiree of the Kansas City, Missouri Police Department, surviving spouse of a Retiree or the spouse of a living Retiree, you are eligible to join the Kansas City, Missouri Police Department Retired Employees Association. Membership is open to all Retirees, which includes Law Enforcement, Civilian and Reserve Officers and their surviving spouse.

- 1) Membership dues for 2024 will be \$20.00 per person regardless of the member's age. Everyone wishing to become a member must now pay annual Association dues <u>And</u> return a member information/beneficiary card to the Association.
- 2) The Association will continue to donate \$200.00 in the event of a member's death. This donation will be paid to the beneficiary of any member that had been a <u>paid</u> member for the preceding three (3) years before their death, regardless of their age, provided they have returned the beneficiary card to the Association every year.

Board members believe it is important to pay our respects and help our fallen members whenever possible. Continuing to aid through our donation is our way of doing so. Please note this donation may be reduced or discontinued at any time, if the Association's funding can no longer support providing it. The Association was formed in an effort to continue the fellowship of our retirees by sponsoring annual social gatherings. Membership dues are collected to support our events and were never collected with the intent to replace the need for insurance for our members. We hope to meet this year, both in late Spring and late Fall. We had a wonderful gathering of retirees this past October!
